# **Conference Summary**

This conference will gather scholars from social, health and built environment sciences to discuss for the first time the biopsychosocial dynamics of prisons and forensic psychiatric institutions, through peoplecentred, trans-disciplinary perspectives. The environment of closed secure spaces contributes to physical and mental health outcomes. We aim at generating evidence-based insights on spaces meant to contain dangerousness, concerning end-users' health and well-being. We will explore the more developed field of prisons and lay the foundations for the un-researched area of forensic built environments. We will investigate positive/negative effects of those places on people's health and their potential to reduce stigma through eco-psychosocial interventions. In two days, experts will debate existing evidence on health and wellbeing. Delegates will participate in co-production workshops on therapeutic secure spaces with experts in co-creative methods. A working group will be generated to outline and establish the field and take things forward, aiming to produce future guidelines.
