ODA Global Innovation Fellowships Scheme 2024

Scheme Notes for Applicants

ANY APPLICATION INCORRECTLY SUBMITTED WILL NOT BE ELIGIBLE FOR AWARD

Applications should be submitted well in advance of the deadline; we recommend at least five days prior to allow for institutional approval.

Programme Aims

1. The objective of the ODA (Official Development Assistance) Global Innovation Fellowships is to provide opportunities to UK-based early- and mid-career researchers from across the humanities and social sciences to develop their skills, networks and careers in the creative and cultural, public, private and policy sectors to address challenges that require innovative approaches and solutions. Through the ODA Global Innovation Fellowships, researchers in the SHAPE community will be supported to create new and deeper links beyond academia, so enabling knowledge mobilisation and translation, as well as individual skills development.
2. This is the first call for this ODA strand of the programme, offering opportunities for ODA Global Innovation Fellowship award holders to embed themselves with a partner organisation. The partner organisation must be based in any of the following countries: Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, South Africa, Türkiye, Thailand, Vietnam and any country from this list of [Least Developed Countries](#).¹
Applications that are not considered ODA-eligible will not be taken forward through the assessment process.
3. This programme is part of the £337m International Science Partnerships Fund, which is designed to enable potential and foster prosperity. It puts research and innovation at the heart of the UK's international relationships, supporting UK researchers and innovators to work with peers around the world on the major themes of our time. It is managed by the Department for Science, Innovation & Technology and delivered by a consortium of the UK's leading research and innovation bodies. In the context of this call, funding from the International Science Partnerships Fund is funded by ODA therefore **applications for this funding must be ODA-eligible.**
4. The aim is to have a mutually beneficial partnership between the fellowship award holder and partner organisation in creative and cultural, public, private and/or policy sectors with each able to take advantage of fresh perspectives and expand their networks and reach. It will enable the award holder to strengthen and create new links outside academia, enabling knowledge mobilisation and translation, and the opportunity to develop new approaches and solutions to societal, cultural, commercial and/or policy challenges through providing a different perspective.
5. **These are offered as awards for up to £150,000 for 12 months in duration (with Full Economic Costing at 80%).**
6. **Applications must be submitted by 6 November 2024, 17.00 (UK time).**
7. The British Academy will hold two webinars for UK-based researchers in the humanities and social sciences and their partner organisations interested in applying for the ODA Global Innovation Fellowships. The aim of the webinars is to provide applicants and partner organisations with a deeper understanding of the aim of the programme and

application process. The webinars will be held 9 July, 14.00-15.00 and 12 September 10.00-11.00. In order to participate and for the webinar to be structured as effectively as possible for you, we ask that you submit a short paragraph outlining your proposal and any questions that you may have, as well as indicate that the applicant and their partner organisation can attend the week before the webinar. Activities and Outputs

8. Successful candidates will be selected on the basis of the quality and interest of the activity or range of activities and outputs proposed in the application. Award-holders will be expected to play a role in promoting the approaches and methods that are the focus of their award, and consider the potential for engagement between academic and non-academic environments. Eligible activities and outputs can involve, but are not limited to:
 - Evidence notes – reports, notes and responses to key challenges/approaches for developing connections with policy leaders or innovators;
 - Data analysis – identifying and analysing datasets that may be relevant to enhancing understanding and framing new solutions;
 - Case studies – exploring practical or policy-orientated solutions, engagement between academic and non-academic environments and the wider benefits to individuals/communities/regions;
 - Briefings/blogs/podcasts/videos and other outputs to reach a variety of audiences and environments, including policymakers (where relevant);
 - Conferences/workshops/webinars/toolkits and other training opportunities which enable knowledge exchange.
9. Successful candidates will be selected on the basis of the quality and interest of the activity or range of activities and outputs proposed in the application, including engagement with and through their partner organisation with local and/or national community, societal, cultural, creative, business and/or policy stakeholders to design, develop and embed the research findings. Award-holders and their partner organisations will be expected to consider the potential for engagement, knowledge exchange, and capacity strengthening between academic and non-academic environments.

Person Specification & Applicant Eligibility

10. The British Academy is inviting applications from early-career and mid-career researchers who are working on the themes outlined below (paragraphs 29-33) who could contribute fresh perspectives to the specified challenges. Please note that applications from independent researchers cannot be accepted in this round of the scheme.
11. Applicants might have expertise from a range of disciplinary, conceptual and methodological perspectives, including analytical, policy and practical perspectives.
12. Eligible applicants must be ordinarily resident in the United Kingdom with a current long-term appointment that will continue for at least as long as the period of the award. You must be an early-career or mid-career researcher based at an institution in the UK (e.g., a Higher Education Institution [HEI] or Independent Research Organisation [IRO]), from disciplines within the Humanities and Social Sciences that is listed as an approving-organisation in the

British Academy's grant management system, Flexi-Grant. This institution will be issued the Terms and Conditions of the award, if successful.

13. In this call applicants must apply with a partner which they have identified, and who will be designated the 'co-applicant'.
14. This is an opportunity for award holders to form new collaborations and draw on the insights this brings to inform, influence and develop their future development. We seek open-mindedness, a willingness to explore new perspectives and to experiment with innovative approaches. You will have an appetite for working across academia, policy and practice, and will demonstrate a commitment to being genuinely challenge driven and dedicated to integrating the perspectives, needs and priorities of the partner organisation.
15. All applicants should strongly consider the potential for engagement between academic and non-academic environments and the value this would bring to their career and the value they can bring to the work and purpose of the partner organisation.
16. Applicants may not hold more than one British Academy award of a comparable nature at any one time.
17. Postgraduate students are **not** eligible to apply for grant support from the Academy, and Applicants are asked to confirm in the personal details section(s) that they are not currently working towards a PhD, nor awaiting the outcome of a viva voce examination, nor awaiting the acceptance of any corrections required by the examiners.

Co-applicant and partner organisation eligibility

18. For ODA Global Innovation Fellowships, the Co-applicant is defined as the main individual from the partner organisation who has prime responsibility of supporting, working with and embedding the award holder into the partner organisation and the wider location. This may include acting as the Lead Applicant's line manager or supervisor.
19. The partner organisation must be based in at least one of the following countries: Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, South Africa, Türkiye, Thailand, Vietnam and/or any country from this list of [Least Developed Countries](#). The Lead Applicant and Co-Applicant must be based at the partner organisation's office in one of these countries throughout the duration of the award.
20. Partner organisations can include: business and commercial organisations, charity and public sector organisations, community organisations, organisations in the creative industries, policy-relevant organisations, think tanks or voluntary organisations. The partner organisation must not be the same organisation at which the Lead Applicant is based.
21. The partner organisation may be working in the creative and cultural, public, private and/or policy sectors. They may not be an academic organisation, such as a university or a research institute.
22. In the application, the researcher must detail the challenge they seek to address and the existing nature of the relationship with the partner (if applicable). The application submitted must be collaborative between the researcher and a collaborator (the Co-

applicant) within the partner organisation. The partner organisation must clearly detail in the application how they will support and embed the Lead Applicant into their work and the wider organisation, as well as the pastoral support inside and outside of work they will be able to offer.

23. The Co-applicant may have a PhD or equivalent experience, but are not required to have an academic background.

Working at and with the partner organisation

24. The Academy regards the partner organisation's engagement with the Fellow as crucial to ensuring a successful ODA Global Innovation Fellowship. Applications should, therefore, demonstrate the partner's strong interest in the Fellowship, how the award holder will be supported, and how the Fellowship will be mutually beneficial to both the researcher and partner organisation.
25. These fellowships must be fully integrated into the partner organisation. Partners are expected to outline plans for the fellow's induction, line management, and pastoral support, as well as the provision of workspace and equipment. Previous experience with receiving and integrating visiting researchers into the organisation is not essential but beneficial. If there is no previous experience of this kind, the partner organisation is encouraged to provide significant detail on how they propose to meet the obligations stated of a partner organisation.
26. The Lead Applicant will agree the outline of a work pattern with the partner organisation, and this should be outlined in the application. Work-planning can be a mixture of demand and self-tasking. An indicative list of tasks could include: undertaking qualitative and/or quantitative research, contributing to existing projects, scoping and/or conceptualising future research interventions, designing and undertaking surveys, writing papers and shorter notes, oral briefings for officials and policymakers, meeting external stakeholders and partners, as well as speaking at events. It is important that the work plan benefits both the award holder and the partner organisation and there is clear added value demonstrated of the award holder and the partner organisation working together in the proposal outlined.

Scope of the Fellowships

27. As well as being based in a partner organisation in one or other of these countries, applications must include a demonstrated focus on Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, South Africa, Türkiye, Vietnam and/or one of the country's in this list of [Least Developed Countries](#).
28. Applications are invited from UK-based researchers in the humanities and social sciences and partner organisations working in any of the following areas:
29. **Environment, Sustainability & Nature:** Applications are welcome from researchers and partner organisations engaged in the broad areas of environment, sustainability and nature. This can include work related to climate change, environmental resilience, energy, biodiversity, just transitions, climate mitigation and adaptation, water, pollution, agriculture, conservation, food, and climate action for example.

30. **Transformative Technologies:** Applications are welcome from researchers and partner organisations engaged in the design, accessibility, development, regulation and implementation of responsible technologies. This can include work related to various technologies such as AI, quantum, vaccines, robotics, and augmented reality, as well as how such technologies will shape the future of work, ways of living, governance and economic development for example.
31. **Health & Wellbeing:** Applications are welcome from researchers and partner organisations engaged in the broad areas of health and wellbeing. This can include work related to the social determinants of health including social protection, education, employment, housing, food insecurity, early childhood development, social inclusion and health services; global health; pandemic preparedness, and antimicrobial resistance for example.
32. **Cities & Urbanisation:** Applications are welcome from researchers and partner organisations engaged in the broad areas of cities and urbanisation. This can include work related to urban space, city policymaking and planning, place-based policymaking, conflict, resilience and adaptation, governance, social inclusion, inequality and poverty, prosperity, climate action, lived experience and representation of the city for example.
33. **Global Order, Geopolitics and International Affairs:** Applications are welcome from researchers and partner organisations engaged in the broad areas of global order, geopolitics and international affairs. This can include work related to foreign policy, international trade and finance, conflict, security, governance, civil society, civic activism, international development, and regional and international institutions for example.
34. There are not any preconceived ideas about the disciplinary background of the award holder, as long as the discipline is within the humanities and social sciences, but the applicant will need to demonstrate a solid understanding of the relevant issues, including the applicable policy, community, civic and/or business landscape and the systemic challenges that it faces.
35. Successful applicants will be expected to be embedded in and produce relevant analysis and research for their partner organisation, and as such will be expected to demonstrate the necessary language skills to work in country. Successful applicants will have the opportunity to engage with wider British Academy work as appropriate.

Equitable Partnerships

36. It is expected that this application and the research it would undertake will be underpinned by partnerships between researchers, institutions and with wider stakeholders. Equity is key to ensuring that these partnerships are effective.
37. Applicants are required to justify the equity within their proposed partnerships. Any applications that are deemed to not support equitable partnerships will not be funded.
38. Applicants will be required to detail how their project will ensure equitable partnerships, including how it will take note that partnerships should: be transparent and based on mutual respect; should aim to have clearly articulated equitable distribution of resources, responsibilities, efforts and benefits; should recognise different inputs, different interests

and different desired outcomes; and should ensure the ethical sharing and use of data which is responsive to the identified needs of society.

ODA Eligibility Criteria

39. This Programme is supported under the International Science Partnerships Fund and this call will fund only ODA-eligible projects.
40. Only research that has a primary objective which is directly and primarily relevant to the problems of [developing countries](#) may be counted as [ODA](#). Applicants are required to demonstrate that the proposal is ODA eligible. ODA eligibility is an essential criterion – projects will only be deemed eligible for funding if they can demonstrate that they satisfy ODA eligibility criteria.
41. You should refer to this [additional ODA guidance](#) document for applicants when developing your proposal.

Duration and Start of an ODA Global Innovation Fellowship

42. ODA Global Innovation Fellowships are required to commence by September 2025. An earlier start date of March or April 2025 may be possible, in this case the applicant will need to explain how they will plan and manage their relocation on this faster timeline.
43. Awards are for one year in duration.

Applicant & Award Flexibility

44. The Global Innovation Fellowships are intended to be flexible awards. The following guidelines will normally apply. However, in exceptional circumstances, additional flexibility may be available. Please contact international@thebritishacademy.ac.uk for further information.
 - a. **Career background and history** – The Academy is aware that individuals will have had different opportunities to balance their research with other commitments during their career or may come from diverse or non-traditional career backgrounds. For example, having taken extended leave including parental or medical leave, or having returned to research following time in other roles or having had periods of significant teaching or administrative workload that may have impacted on the applicant's research. There is a question in the application form (the personal statement) that will enable applicants to provide further information so that the Academy can take this into account when assessing applicants' track record.
 - b. **Reasonable adjustments** – Applications from researchers with disabilities are welcome and encouraged. The Academy will provide adjustments to ensure they can participate fully in the selection process. If an adjustment is required when accessing the application form or for any other part of the application process then please contact international@thebritishacademy.ac.uk. In addition, costs that are required for the researcher to undertake their award will be considered eligible regardless to what is set out in paragraph 40 below. The Academy welcomes any questions applicants may have on this matter. The costs of reasonable adjustments required to support researchers with disabilities will also be an eligible cost throughout the duration of the award.

- c. **Childcare arrangements** - Provision for the cost of childcare support will be considered as part of the allowable research expenses during the award for the award holder funded through the grant when undertaking activity related to the grant, such as travel to conferences. This includes instances where the award holder wishes to support their child(ren) themselves, such as travelling with them whilst undertaking their research.
- d. **Relocation and visa arrangements** - The Academy will cover relocation costs for the award-holder during the award, as well as their dependents. The cost of a visa and any associated costs for the applicant and their dependants are eligible under this programme.
- e. **Portability of awards** – If the award holder moves UK host organisation before the start or during the award, the award will be moved to the new UK host organisation provided that the new host is an eligible UK-based host organisation.

Value of funding and support provided

- 45. The award will have a maximum award value of £150,000 on an 80% Full Economic Costing (FEC) basis.
- 46. 80% FEC is understood in the following manner:

Cost Category	FEC contribution
Directly incurred staff costs including PI and team salary and oncosts.	80%
Other Directly Incurred including travel, accommodation, top-up contribution, visas and consumables	100%
Directly Allocated (including estates costs) and Indirect Costs	80%

- 47. The grant awarded is expected to be used solely for the purposes specified in the application and agreed in the award-letter.
- 48. The award is intended to be made on a full-time basis.
- 49. The Academy recognises that the upper limit on the contribution that the Academy’s funding can make to this award – £150,000 – might not be sufficient to cover all of the costs up to 80% of the Full Economic Cost value required. In those cases, an employing institution will be expected to make additional contributions to the overhead costs involved.

Eligible costs

- 50. Funding will be provided on the Full Economic Costing (FEC) basis primarily to cover the salary of the Applicant. The Innovation Fellow will be expected to spend their time in the partner’s office and/or other mutually agreed sites.
- 51. The Academy will provide 80% of the FEC of the Fellowship. The Academy requests that the 80% FEC cost figure is entered into the application form (not the 100% FEC figure). The maximum value of the award made by the Academy is £150,000, meaning that the total cost of the Fellowship at 100% FEC may be up to £187,500. This includes all direct and indirect costs incurred by the employing institution, including space, central support services, and other necessary costs incurred by the employing institution on behalf of the Fellow.

52. Eligible costs will be funded under the following headings:

- **Directly incurred salary costs.** The award can be used to support the employing institution's salary costs of the Applicant for the duration of the award
- **Estates and indirect costs.** The award can include the employing institution's estate and indirect costs incurred as a result of direct staff costs.
- **Relocation and visa costs.** The Academy will pay for reasonable relocation costs including return travel between the country of residence and the location of the partner organisation.
- **Accommodation and top-up contribution.** The Academy will pay for reasonable accommodation costs in the location of the partner organisation. The top-up contribution is for living expenses in the location of the partner organisation and can be used flexibly by the award holder as their needs require.

Non-eligible Costs

53. The following items are **not eligible** for funding (applicants registered with special needs may consult the Academy about possible exceptions prior to application):

- **Directly allocated salary costs.** No directly allocated costs can be attributed to this award.
- purchasing of assets;
- equipment costs;
- computer hardware including laptops, electronic notebooks, digital cameras, etc;
- books and other permanent resources;
- the preparation of camera-ready copy, copy-editing, proof-reading, indexing, nor any other editorial task;
- subventions for direct production costs (printing, binding, distribution, marketing etc);
- costs of publication in electronic media;
- carbon offsetting;
- open access fees.

Gender Equality

54. Research and innovation (R&I) activities funded by the Department of Science, Innovation and Technology (DSIT), provided through Partner Organisations, comply with the requirements of the [DSIT R&I Gender Equality Policy](#), which states that activities must tackle instances of underrepresentation, differential needs and systemic disadvantage to improve the relevance of R&I findings that support the inclusion, reduce the impact of bias, and ultimately, contribute to reducing inequalities among genders. This includes but is not limited to Official Development Assistance activities, in line with the International Development (Gender Equality) Act 2014.

55. All applicants are strongly recommended to thoroughly review the above publication before designing and drafting their application.

56. All applicants must submit as part of their application a gender equality statement, which must meet compliance standards as set out in the above publication. All applications will be reviewed at the eligibility and assessment stages to ensure they meet the necessary

requirements. Not meeting the necessary requirements will mean that applications are automatically not fundable.

Research Ethics

57. Applicants must ensure that the proposed research will be carried out to a high ethical standard. They must confirm that any potential ethical issues have been considered and explain how these will be addressed. The Academy requires all research it funds to be conducted in an ethical manner, with due consideration given to ethical questions arising, including safeguarding and equitable partnerships.
58. The host institution is responsible for ensuring that ethical issues relating to the research project are identified and brought to the attention of the relevant approval or regulatory body.
59. Ethical approval to undertake the research must be granted by the relevant authority before any work requiring approval begins. Wherever necessary, appropriate consent should be obtained from or on behalf of participants or others affected by the research.
60. Applicants will be asked to indicate whether their proposed research raises any special ethical issues, and whether their application has been approved by the host institution's Research Ethics Committee or other relevant authority.
61. Any host organisation should meet the requirements of the [Concordat to Support Research Integrity \(2019\)](#) and subsequent amendments and must have in place formal procedures for governing good research practice and for handling and reporting allegations of fraud or research misconduct.

Risk Management

62. Researchers funded under this programme may choose to undertake fieldwork in the course of the research project. We expect an assessment with appropriate mitigation suggested of any risks entailed within the research project to be outlined within the proposal (for example, risks associated with the delivery of the research, financial management and oversight/governance).
63. Research groups will be required to indicate if (and where) they intend to undertake research in the field. For countries/regions considered by the UK Government's Foreign, Commonwealth and Development Office as a host nation of medium or high risk, the application will also require researchers to demonstrate that the PI (and the PI's host institution) understands the risk management implications and can monitor and manage the risks effectively. This should include, but need not be limited to, any risks that researchers will encounter in an area of civil unrest, violence and/or crime. This aspect will be explicitly covered in the approval of any application by the appropriate authorities at the PI's host institution, to confirm that the duty of care responsibility rests with the host institution.

Timetable

64. The deadline for applications to be submitted to this call is **Wednesday 6 November 2024 at 17.00 (UK Time)**. This includes the employing institution approver approving

the completed application by the submission deadline. Any applications submitted after that deadline will be ineligible.

65. The final awards panel will meet after the call for applications are closed.

66. Decisions are expected to be communicated by the end of January 2025.

Reporting

67. Award holders are required to complete three reports:

- An interim report at the mid-point of the Fellowship reporting on progress and lessons learnt to date.
- A final report from award holders within three months of the award's end, detailing the progress of the activities in which they participated.
- A post-award report three years after the award's end showing the impact of the award on their subsequent career.

Head of Department Supporting Statement

68. Applicants are required to obtain a statement of support from their Head of Department as part of this application.

69. The Head of Department should be the person who heads the Department, Faculty, Institute or other unit of an Independent Research Organisation (IRO) in which you are currently working. As Head of Department, they will be expected to comment their level of support for the application and on the career development benefit to be gained by the Applicant if the award is made. They will be expected to also confirm that the Applicant will be released from duties at the employing institution for the duration of the award and be able to return to the employing institution once the award ends.

70. Please note that the Head of Department statement must be received before you can formally submit the application for approval, and you are strongly advised to ensure that your Head of Department submits the statement well in advance of the formal applicant deadline for this round of competition as noted above.

71. If the Applicant is also Head of Department, the statement must be provided by another suitable individual, e.g., Deputy Head or Head of School.

72. Heads of Department must be invited to contribute to your application via the Flexi-Grant system. Please see further guidance below:

- They can be invited through the 'Contributors' tab displayed on the application form summary page. Once they have been invited, they will receive an email notification with instructions on how to contribute.
- You can monitor the progress of your participants' activity through this section of the application form, and issue reminders as required. Once the recipient has accepted your invitation, their status will be displayed as 'active'. Upon completion of their section of the application form, their status will be displayed as 'complete'.

- Once participants have completed all their sections of the application form, please remind them to select 'Save & Submit' on the application form page or select 'Submit your contribution' on the summary page.
- You will not be able to submit your application form until the status of all participants shows as 'complete' in the 'Contributors' tab.

73. **Please also note that an application cannot be submitted until all required contributors have submitted their contribution first. We recommend that supporting participants fulfil their requirements at least 5 working days before the submission deadline to ensure there is sufficient time for organisational approval.**

74. **The employing institution approver must approve the completed application by the submission deadline.**

Selection Criteria

75. All eligible proposals submitted in response to this call will be assessed by relevant peer reviewers and then considered by a final selection panel.

76. Applications will be assessed against the following criteria:

- a. The research expertise of the lead applicant and alignment with the chosen theme from paragraphs 29-33 above, their experience and/or interest in knowledge exchange and their track record working in the chosen country and/or ODA work;
- b. The feasibility of the proposal to achieve the programme of work outlined and its anticipated benefit and impact for the lead applicant's future knowledge exchange ambition;
- c. The demonstrated ability and commitment of the co-applicant and partner organisation to effectively embed the lead applicant in the partner organisation and a new location including any past relationship this application may be building on, as well as the benefit of the proposal to the co-applicant and partner organisation;
- d. Evidence that the project is ODA-eligible. Only projects that demonstrate that they satisfy ODA eligibility criteria will be eligible for funding;
- e. Whether the gender equality statement meets or exceeds the minimum standard as set out in the [Gender Equality in Research and Innovation](#) policy;
- f. Value for money.

77. All applicants will be notified of the outcome of the application in January 2025.

78. The approving organisation will be asked to give its consent before the award is confirmed.

Application and Assessment Procedure

79. All applicants must register in the British Academy's online [Flexi-Grant](#) system to enable the processing and assessment of their application. All applications must be submitted in English.

80. All applications will be subject to an eligibility check undertaken by appropriate British Academy staff before being put forward for assessment, and **applications that are not completed correctly and on time will not be considered.**

81. The deadline for submissions and UK institutional approval is **6 November at 17.00 (UK time)**. **Applicants will not be allowed to make any changes to their applications or submit any additional information after the 6 November deadline.**

Code of Practice

82. The Academy has a Code of Practice for assessing research applications, setting out the principles of equity, integrity and confidentiality governing the treatment of all applications for research support. The Code of Practice also covers Data Protection, the Academy's ethics policy and the appeals procedure. 83. Applicants will not be allowed to make any changes to their applications or submit any additional information after the **6 November** deadline. **When completing your application on the British Academy Flexi-Grant® GMS, it is recommended that you take particular note of the following points:**
